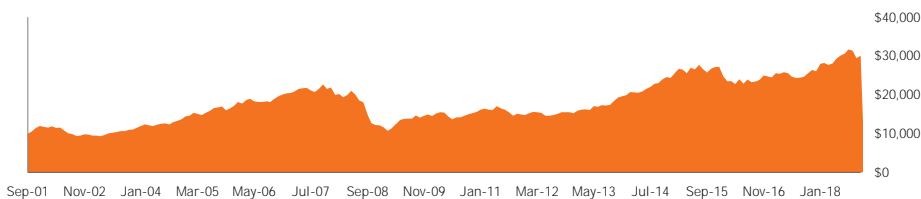

GROWTH OF \$10,000 SINCE INCEPTION - SERIES F

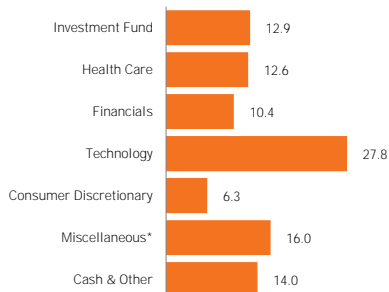
